Duh!!!

Recently, while watching a debate between local candidates, sponsored by the League of Women Voters on public access TV, it became obvious to me that the candidates did not know the actual authority for, nor the limits of, the office they are seeking. That's when it dawned on me that we Constitutional Patriots have overlooked an obvious way to force politicians to recognize these authorities and limits – and hopefully helping to turn them into statesmen – while educating the public at the same time.

Purpose

The purpose of the League is to survey candidates seeking public office in order to determine:

- whether they understand the lawful functions of the office they seek, and the legal limits to those functions:
- whether they understand the United States Constitution, the Constitution of the State in which they seek public office, and the laws made in conformance to them; and
- their attitude towards the unalienable Rights of Citizens, and ultimately their dedication to securing those Rights.

Use of information obtained by survey or questionnaire

The information received by the League from the candidates by the cut-off date:

- will be published on *The League of Informed Voters* website upon receipt of each candidate's questionnaire; and
- will be published in a newspaper of general circulation within the election district of the public office sought.

The League of Informed Voters is a subsidiary of the Save-A-Patriot Fellowship, and is administered by the Fellowship's staff, under the direction of the Fellowship's fiduciary.

It is self-evident that with the implementation of the League's program, candidates will be forced to investigate the law which authorizes the elective office they seek, and so be exposed to the limits on that office. If the candidate has less than honorable intentions, he will be very hesitant in carrying them out, and if he does, his published response to the questionnaire would reveal his criminal intent.

It is also evident that by publishing the completed questionnaire just before the election in a newspaper of general circulation in the election district, we will educate the public, and help to offset the effects of groups like the socialist-leaning League of Women Voters. No matter how you look at it, you have to come to the conclusion that it is a win-win situation. What's more, affiliate League chapters across these States united will go a long way in correcting

the problem of run-away government. It is to the advantage of every Patriot to join the League of Informed Voters, support it, and start a local chapter in your area.
